## **Generic Marking Principles**

These general marking principles must be applied by all examiners when marking candidate answers. They should be applied alongside the specific content of the mark scheme or generic level descriptors for a question. Each question paper and mark scheme will also comply with these marking principles.

GENERIC MARKING PRINCIPLE 1:

Marks must be awarded in line with:

- the specific content of the mark scheme or the generic level descriptors for the question
- the specific skills defined in the mark scheme or in the generic level descriptors for the question
- the standard of response required by a candidate as exemplified by the standardisation scripts.

GENERIC MARKING PRINCIPLE 2:

Marks awarded are always whole marks (not half marks, or other fractions).

GENERIC MARKING PRINCIPLE 3:

Marks must be awarded **positively**:

- marks are awarded for correct/valid answers, as defined in the mark scheme. However, credit
  is given for valid answers which go beyond the scope of the syllabus and mark scheme,
  referring to your Team Leader as appropriate
- marks are awarded when candidates clearly demonstrate what they know and can do
- marks are not deducted for errors
- marks are not deducted for omissions
- answers should only be judged on the quality of spelling, punctuation and grammar when these features are specifically assessed by the question as indicated by the mark scheme. The meaning, however, should be unambiguous.

GENERIC MARKING PRINCIPLE 4:

Rules must be applied consistently, e.g. in situations where candidates have not followed instructions or in the application of generic level descriptors.

GENERIC MARKING PRINCIPLE 5:

Marks should be awarded using the full range of marks defined in the mark scheme for the question (however; the use of the full mark range may be limited according to the quality of the candidate responses seen).

GENERIC MARKING PRINCIPLE 6:

Marks awarded are based solely on the requirements as defined in the mark scheme. Marks should not be awarded with grade thresholds or grade descriptors in mind.

5	<ul> <li>Discuss: write about issue(s) or topic(s) in depth in a structured way.</li> <li>Eight from:</li> <li>Pilot running is one department trying out/implementing the new system before implementing in all other departments.</li> <li>Benefits:</li> <li>If the new system fails/does not work properly then only a</li> </ul>	8
	<ul> <li>part/section/department is affected while the others are not</li> <li>Implementation is easier to manage as on smaller scale/affects less users/staff/employees at once than a full direct changeover/other methods of implementation</li> <li>Staff/users/employees can be trained in small groups/by department/section</li> <li>Staff/users/users/employees will/can learn from mistakes made by group using pilot system</li> <li>Trained staff can assist/support training of other staff</li> <li>Only one part of the company is changed over so the implementation costs can be phased over a longer period of time <ul> <li>which may save the company money/having to pay large sums at once/cost of complete shut down during changeover/cost of parallel running</li> </ul> </li> </ul>

	<ul> <li>Hierarchical/layered/graphical description of the scope of a project/project scope to show to e.g., stakeholders/project participants/developers/management/team leaders</li> <li>Describes in detail all the work required in all the stages of a project so that everyone knows what is/has to be done</li> <li>Describes the planned outcomes of the project so that they can be tested/evaluated in later stages</li> <li>Each layer describes all/100% of layers below/following it so that it is known what is/has been done to reach the stage.</li> </ul>

	<ul> <li>Content/descriptions can be easily understood by all participants</li> <li>Content/work can be managed/divided into manageable units         <ul> <li>Content/work units independent/separate from each other</li> <li>so work/responsibility can be assigned to individuals</li> <li>so can be clearly assigned to individuals</li> </ul> </li> <li>Duration of work can be estimated/shown giving time for completion/allowing costs to be determined</li> <li>Content/work is measurable allowing start/end dates/time to be estimated calculated</li> <li>Content/work units can be integrated/collected together with other units to create whole project</li> <li>WBS is adaptable to cope with amendments/alterations/changes to project scope.</li> </ul>

	<ul> <li>so anticipate any higher costs/decide whether or not to implement the changes</li> <li>Quality/detail of specifications/requirements provided to customers/clients can be improved by examining/testing prototypes</li> <li>Avoidance of potential disasters at end of project/development         <ul> <li>as these are discovered in early prototypes rather than in final product</li> <li>Discovery of problems/issues in prototypes</li> </ul> </li> </ul>	
	<ul> <li>results in lower costs/reduced time taken for development</li> <li>Prototyping requires greater customer/client involvement in development/at all stages of development         <ul> <li>so enables clients to see/use/interact with a working model of their project</li> <li>means clients are more aware/involved with development</li> </ul> </li> </ul>

10(a)	<ul> <li>Two from:</li> <li>(Clearly defined black/white/colour) areas in the bitmap are automatically traced (in graphics software) to create objects in the vector image</li> <li>Nodes/anchors/control points are added to the objects</li> <li>Object manually corrected by user to merge shapes/redefine areas/adjust borders of shapes</li> <li>Colour resolution/number of bits (may be) reduced by user/software to reduce file size/more clearly define areas.</li> </ul>	2
10(b)	<ul> <li>Discuss: write about issue(s) or topic(s) in depth in a structured way</li> <li>Six from:</li> <li>Benefits: <ul> <li>Vector images are easier to edit/modify by moving/amending nodes/pathways</li> <li>Editing/resizing/scaling a vector image does not affect the quality of the image/does not pixelate on enlarging/zooming into an area</li> <li>Vector images can have smaller file size (for a given image size) <ul> <li>do not use/require as much disk space for storage</li> <li>download faster than bitmap image</li> <li>so can be used/displayed on low-power/small storage space devices/tablets</li> </ul> </li> <li>Edges/lines are smooth(er) in vector images/can be edited/moved without jagged/pixelated appearance</li> <li>producing a higher quality image/lines</li> </ul> </li> <li>Drawbacks: <ul> <li>Photographs do not appear realistic</li> <li>because vector images/gradations of colour/surfaces are unrealistic in photographs</li> </ul> </li> <li>Small/minor drawing/editing errors/mistakes are more visible in vector images than in bitmap images <ul> <li>which reduces the image quality</li> </ul> </li> <li>Adding special effects is more difficult when editing vector graphics compared to bitmap images</li> <li>High performance computing devices are required to carry out the calculations/recalculations when edits are made in vector images</li> </ul>	6
